Update on Finance Committee and Property

The Executive Director updated the Program Committee on Finance Committee activities:

- PacMed lease for the Clinic space is awaiting to be signed.
- The Executive Director is discussing Quarters leasing and feasibility studies with Commerce
- Master Plan study is continuing with Makers. Scoping the work differently with proviso funds from Commerce and with fluctuating Quarters activities. The Committee asked about commitments and expectations from Commerce proviso funds.
- SCIDpda is preparing to close and break ground this autumn.

Grant Management

Update on contracting for 2021 New and Renewal Major Grants

The Associate Director updated the Committee on contracting for 2021 New and Renewal Major Grants.

- Exhibits are being revised and New Major and Renewal Major Grant contracts are to be signed.
- Contract meetings will be scheduled through the end of June.

Update on 2021 Health Equity Scholars

The Associate Director reported on 2021 Health Equity Scholars.

- Had preliminary conversations with all three Scholars. One of them lives out of state.
- Their studies will be on: 1) Local immigrant/refugee service gaps and overlaps. 2) Local HEP B screening and referrals for immigrant/refugee. 3) Maternal health disparities at community levels.
- The Committee discussed incorporating equity and anti-racism work with the PDA Scholars.

Update on Seattle University School of Law Health Law Policy Clinic Proposal

The Executive Director discussed potential activities with Seattle University School of Law.

 He discussed partnership with the University's Health Policy Law Clinic for work on advocacy policies and connecting work with Olympia legislature.

Grantmaking

Incorporating Equity Into Grantmaking

The Associate Director and Committee Chair facilitated discussions on Incorporating Equity into Health Equity Fund Grantmaking.

- The Associate Director discussed LOI process and potential conversations with grantees invited for Full Applications. The Committee expressed support for shaping the application process with grantee conversations to include anti-racism and equity, sharpening applications individually.
- The Committee discussed evaluation, language used by grantees, Resilience Funding for grantee staff, and metric/data analysis through an equity lens.
- "From Information to Data to Knowledge to Truth to Action to Justice." Value of information should be purposeful. Data collected by grantees should be meaningful.
- The Chair suggested honing into discussing data and equitable evaluation/reporting in future Program Committee meetings.

Strategic Plan

Technical Assistance and Increased Community Building Among Grantees

The Executive Director and Associate Director discussed Technical Assistance and other grantee activities to increase community among grantees.

- The Executive Director framed potential work and growth into working with the full Strategic Plan. He's had discussions with Marc Provence to assist with developing a plan.
- The Committee discussed increased programmatic work with grantees such as potential ad-hoc cohorts and facilitation of grantee peer meetings.
- Grantmaking, community building, advocacy, and communication achievements and aspirations were discussed.
- The Committee requested working with cohorts to ask what they need. Cohort meetings are to be
 optional and not a requirement. The Committee further discussed project management with goals
 and deliverables. Consultations and work could include Program Committee members, Governing
 Council members, and other potential community volunteers.
