Doris Koo called the meeting to order at 3:35 PM. A guorum was present. There was no public comment.

Executive Director Succession

Resolution 03-2023 Appointment of Executive Director

Governing Council Acting Chair Doris Koo provided an overview of the Executive Director resignation and potential candidate processes.

- The Council created a four-member Search Group (Bob Cook, Douglass Jackson, Martine Pierre-Louis, and Doris Koo).
- The Group followed similar processes from the previous Executive Director search.
- Staff conducted an interview and followed up with the Acting Chair.
- The candidate provided a presentation to the entire Governing Council during the regular April Governing Council meeting.
- The Group decided to move the candidate forward and the Acting Chair started reference checks.
- The start date has been agreed upon for May 15 and a salary has been confirmed.

The Council discussed Resolution 03-2023, thanked the Acting Chair, Search Group, PHPDA Staff, and Legal Counsel for the smooth process and transition.

- The Acting Chair asked that the Communications Manager work with Pyramid for a joint communications plan with Chief Seattle Club in drafting and publishing a coordinated announcement.
- PHPDA Legal Counsel reminded the Council that employment is still subject to the Acting Chair's reference checks and subject to contract negotiations.
- An updated job description, interview questions, candidate's resume, and reference notes will be
 physically held by the PDA's Legal Counsel and at a secured PHPDA location.

The Governing Council voted to approve Resolution 03-2023, authorizing the Acting Chair of the Governing Council to complete and negotiate an employment contract with Virgil Wade as PHPDA Executive Director. (Moved/2^{nded} by Bob Cook/AyeNay Abye, 7 of 7 in favor)
