Douglas Jackson called the meeting to order at 5:32 p.m. There were no public comments.

Douglass Jackson shared the news that a council member will be resigning from the council but would like to participate in the transformation process. Governance

Acting Executive Director duties and related compensation (Resolution 09-2025)

Douglass Jackson introduced Resolution 09-2025. The resolution was drafted by the organization's legal counsel. It covers updated duties and compensation for the Acting Executive Director role. Christina Bernard was appointed the Acting Executive Director at the March 11 meeting and will serve in that role until an interim Executive Director is identified and begins work. Douglass shared he met with her last week to discuss the details. Douglass Jackson asked for a motion to approve the Acting Executive Director duties and related compensation (Resolution 09-2025). Nancy Sugg moved. Martine Pierre-Louis seconded. All were in favor.

Procedure and process for hiring the Interim Executive Director

Douglass Jackson provided background information on the development of a hiring process plan for the Interim Executive Director. The hiring committee also drafted interview questions. It was noted that as proposed in the plan, interviews would have to be noticed as special meetings if a quorum of the council attends. The council had a discussion on their feedback and suggestions on the draft questions, as well as the process. The hiring committee will incorporate their feedback in their next draft. The interviews will be conducted by the committee only, with finalist(s) recommended to meet with the full council.
