Update on Quarters Planning

Two governing council members reported that the \$5million in funding for capital work on the Quarters was successfully reprogrammed into supporting intergenerational and large family housing. The final legislative state budget is expected to pass soon. PHPDA will reach out to additional elected officials regarding the project, including County Councilmember Teresa Mosqueda. There is a tour of the buildings scheduled for June. The invitation was extended to other members of the council. A councilmember suggested that the PHPDA real estate consultant should draft an MOU soon. The council discussed the uncertainty surrounding HUD funding and the potential cost effects of tariffs.
